We are pleased to announce the Call for Nominations for the NATHEALTH HealthCare CSR Awards 2023. Nominations for the awards are invited to be submitted on or before the deadline - 17:00 IST on 27th February 2023

The NATHEALTH Healthcare CSR Awards will identify and felicitate corporates and other philanthropic organizations practicing commendable healthcare CSR initiatives and recognize companies' efforts in integrating and internalizing CSRs into their everyday thinking. The awards do not carry any monetary value but serve to recognize and celebrate extraordinary contributions. Nominations are invited across four award categories.

AWARD CATEGORIES

1. Health Technology Innovations
2. Community Based Health Solutions
3. Environmental Health
4. COVID-19 Preparedness and Resilience

ELIGIBILITY CRITERIA

- The applicant organization should be a CSR donor, foundation, or an implementing agency.
- The project applied for the award should be a CSR funded project.
- The project can be of any duration, but the completion date must not be later than 31st December 2022.
- Award applicants need not be a member of NATHEALTH.
- One project can apply under maximum two categories but shall be considered as only one nomination.

SELECTION PROCESS

Nominations will be reviewed and selected by an independent Awards Committee. The evaluation shall be done based on Innovation, Sustainability, Scalability, Equity, Inclusiveness of the project and it's Public Health impact for each of the categories. The shortlisted nominations shall be invited to present the project to the jury on an online mode.

ANNOUNCEMENT OF AWARDS

The Award Committee will announce the award during the NATHEALTH Annual Summit on 23rd of March 2023. The winners will be given an opportunity to share their experience for 3 minutes about the project to the larger audience at a national level.

NOMINATION DEADLINE
